**RENEWING CONTRACT FOR EXAM GLOVES FOR

WHEREAS, the current contract for exam gloves for Sunny Hill will expire on November 30, 2013,
and

WHEREAS, the current contract with Professional Medical, New Lenox, IL, allowed for two (2), one
(1) year renewal options, if the County desired to do so, and

WHEREAS, the Purchasing Director and Sunny Hill Administration have recommended, and the
Public Health & Safety Committee has concurred, that the contract for exam gloves with Professional
Medical, New Lenox, IL, be renewed for an additional year, until November 30, 2014. The estimated annual
contract amount will remain at \$28,511.55, as stated on the original bid documents.

NOW, THEREFORE, BE IT RESOLVED, that the Will County Board hereby renews the contract for
exam gloves for Sunny Hill Nursing Home with Professional Medical, New Lenox, IL.

BE IT FURTHER RESOLVED, that such purchases shall be funded through the Sunny Hill Nursing
Home Budget.

BE IT FURTHER RESOLVED, that the Preamble of this Resolution is hereby adopted as if fully set
forth herein. This Resolution shall be in full force and effect upon its passage and approval as provided by
law.

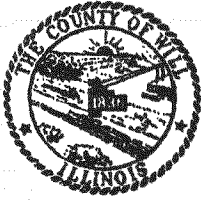

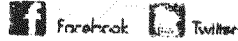
