



**RESOLUTION OF THE COUNTY BOARD
WILL COUNTY, ILLINOIS**

Award of Bid for CCTV Upgrades at the Adult Detention Center

WHEREAS, the Will County Sheriff has requested to replace the analog Digital Video Recording System (DVR) at the Adult Detention Center, due to system failures and outdated software with a software based CCTV System, and

WHEREAS, in order to obtain the most competitive rates for said upgrades at the Will County Adult Detention Center, proposals were solicited, and

WHEREAS, on July 28, 2014, the County Executive's Office opened five (5) bids for the CCTV System Upgrades, and

WHEREAS, the County Executive's Office, the Will County Sheriff's Office and Stromsland & DeYoung Architects have recommended, and the Finance Committee and Executive Committees have concurred, that a contract be entered into with the lowest responsible bidder of Stanley Convergent Security, Noblesville, IN, for a total base cost of \$578,000.00, and

WHEREAS, this project is to be funded with appropriations from the Capital Improvements line item.

NOW, THEREFORE, BE IT RESOLVED, that the Will County Board hereby awards the bid for the CCTV System Upgrades at the Adult Detention Center to the lowest responsible bidder of Stanley Convergent Security, Noblesville, IN, for a total base cost of \$578,000.000.




