



**RESOLUTION OF THE COUNTY BOARD
WILL COUNTY, ILLINOIS**

Renewing Contracts for Refuse & Recycling Collection for Various County Buildings

WHEREAS, the current contracts for refuse and recycling services for various county buildings expire on November 30, 2017, and

WHEREAS, Waste Services Department has recommended, and the Executive Committee has concurred, that the contract for refuse and recycling collection services be renewed with Homewood Disposal/NuWay, Homewood, IL, for refuse and recycling collection services, and with Republic Services, Joliet, IL, for public recycling drop-off sites, with CPI increase of up to 5% from original contracts, commencing December 1, 2017, through and including November 30, 2018, and

WHEREAS, sufficient appropriations were budgeted in the respective Budgets.

NOW, THEREFORE, BE IT RESOLVED, that the Will County Board hereby authorizes the County Executive to renew the contracts with Homewood Disposal/NuWay, Homewood, IL, for refuse and recycling collection services, and with Republic Services, Joliet, IL, for public recycling drop-off sites, with CPI increase of up to 5% from original contracts, commencing December 1, 2017, through and including November 30, 2018, pursuant to the terms and conditions contained in the original bid.

BE IT FURTHER RESOLVED, that the Will County Board hereby authorizes the Will County Executive to take such action as necessary to implement the bid award set forth herein.



Adopted by the Will County Board this 16th day of November, 2017.


