



**RESOLUTION OF THE COUNTY BOARD
WILL COUNTY, ILLINOIS**

Awarding Bid for Diabetic Supplies for Sunny Hill Nursing Home

WHEREAS, in order to receive the most competitive price available, the Will County Executive's Office solicited bids for diabetic supplies for Sunny Hill Nursing Home, and

WHEREAS, on June 2, 2017, the Will County Executive's Office opened six (6) proposals for the diabetic supplies, and

WHEREAS, after reviewing such proposals, the recommendation is to award the bid to the lowest responsible bidder of Medline Industries Inc, Northfield, IL, for an approximate total bid price of \$8,112.00 for the 1st year. The contract period is September 1, 2017 through and including August 31, 2018, with two (2) additional renewals, if the county so chooses. The cost for optional 2nd and 3rd years, if considered at that time, will increase, as the vendor listed a 2% increase on their bid form. The approximate grand total for all three (3) years would be \$24,825.96, and

WHEREAS, the Public Health & Safety Committee concurs with this request.

NOW, THEREFORE, BE IT RESOLVED, that the Will County Board hereby awards the contract for diabetic supplies for Sunny Hill to the lowest responsible bidder of Medline Industries Inc, Northfield, IL, for an approximate total bid price of \$8,112.00 for the 1st year. The contract period is September 1, 2017 through and including August 31, 2018, with two (2) additional renewals, if the county so chooses. The cost for optional 2nd and 3rd years, if considered at that time, will increase, as the vendor listed a 2% increase on their bid form. The approximate grand total for all three (3) years would be \$24,825.96.


BE IT FURTHER RESOLVED, that such purchases shall be funded through Sunny Hill Nursing Home's Budget.

Adopted by the Will County Board this 20th day of July, 2017.


