



**RESOLUTION OF THE COUNTY BOARD
WILL COUNTY, ILLINOIS**

Awarding Contract for Security Guard Services at Sunny Hill Nursing Home, Adult Probation and Workforce Services

WHEREAS, the current contract for security guard service at Sunny Hill Nursing Home, Adult Probation and Workforce Services expires on November 30, 2016, and

WHEREAS, on September 27, 2016, the County Executive's Office opened four (4) bids to provide security guard service at Sunny Hill Nursing Home, Adult Probation and Workforce Services, and

WHEREAS, the Sunny Hill Nursing Home Administrator and the Purchasing Director have recommended, and the Executive Committee concurs, that the contract for security guard service for unarmed security guard services at Sunny Hill Nursing Home be awarded to the lowest responsible bidder, DSI Security Services, Chicago, IL for approximately 5,840 hours per year, (one guard per shift/two shifts per day, Sunday through Saturday, including holidays, beginning December 1, 2016 through November 30, 2017, with two (2) additional one (1) year renewal options, at the discretion of Will County, for a total first year contract of \$78,840.00, and

WHEREAS, the Adult Probation Assistant Director and the Purchasing Director have recommended, and the Executive Committee concurs, that the contract for security guard service for taser-armed security guard services at Adult Probation be awarded to the lowest responsible bidder, Per Mar Security Services, Westchester, IL for approximately 1,984 hours per year, (one guard per shift) beginning December 1, 2016 through November 30, 2017, with two (2) additional one (1) year renewal options, at the discretion of Will County, for a total first year contract of \$38,688.00, and

WHEREAS, the Workforce Services Administrative Manager and the Purchasing Director have recommended, and the Executive Committee concurs, that the contract for security guard services for unarmed security guard services at Workforce Services be awarded to the lowest responsible bidder, Per Mar Security Services, Westchester, IL for approximately 1,984 hours per year, (one guard per shift) beginning December 1, 2016 through November 30, 2017, with two (2) additional one (1) year renewal options, at the discretion of Will County, for a total first year contract of \$31,744.00, and

WHEREAS, sufficient appropriations will be budgeted in the Sunny Hill Nursing Home, Adult Probation and Workforce Services Budgets for these purposes.

NOW, THEREFORE, BE IT RESOLVED, that the Will County Board hereby awards the contract for security guard service for unarmed security guard services at Sunny Hill Nursing

Home be awarded to the lowest responsible bidder, DSI Security Services, Chicago, IL for approximately 5,840 hours per year, (one guard per shift/two shifts per day, Sunday through Saturday, including holidays, beginning December 1, 2016 through November 30, 2017, with two (2) additional one (1) year renewal options, at the discretion of Will County, for a total first year contract of \$78,840.00, based upon the attached Bid History Sheet.

BE IT FURTHER RESOLVED, that the Will County Board hereby awards the contract for security guard service for taser-armed security guard services at Adult Probation be awarded to the lowest responsible bidder, Per Mar Security Services, Westchester, IL for approximately 1,984 hours per year, (one guard per shift) beginning December 1, 2016 through November 30, 2017, with two (2) additional one (1) year renewal options, at the discretion of Will County, for a total first year contract of \$38,688.00, based upon the attached Bid History Sheet.

BE IT FURTHER RESOLVED, that the Will County Board hereby awards the contract for security guard services for unarmed security guard services at Workforce Services be awarded to the lowest responsible bidder, Per Mar Security Services, Westchester, IL for approximately 1,984 hours per year, (one guard per shift) beginning December 1, 2016 through November 30, 2017, with two (2) additional one (1) year renewal options, at the discretion of Will County, for a total first year contract of \$31,744.00, based upon the attached Bid History Sheet.




