



**RESOLUTION OF THE COUNTY BOARD

Voiding Bid for Communication Headsets - SWAT

WHEREAS, in order to receive the most competitive price available, the Will County Executive's Office solicited bids for Communication Headsets for SWAT, Sheriff's Department, and

WHEREAS, on June 30, 2018, the Will County Executive's Office opened three (3) proposals, and

WHEREAS, two bids were received on the correct manufacturer's part number, and one bid on an incorrect part number. After review and consideration it was determined to void the bids due to bidders inconsistency in bidding on the correct part number. Permission is being requested to void the bid, make necessary changes and re-issue the bid as altered, and

WHEREAS, Staff has recommended that the bid for Communication Headsets for SWAT, Sheriff's Department, be voided and requests permission to reissue the bid, and

WHEREAS, the Executive Committee concurs with their request.

NOW, THEREFORE, BE IT RESOLVED, that the Will County Board hereby voids the bid for Communication Headsets for SWAT, Sheriff's Department, and authorizes Staff to work with the Will County Purchasing Director to redesign the bid specifications and reissue as altered.




