Natalie Manley; Intro to her office/position & Veteran Services- Manley states next session is 1/4/2022-thru 4/1/2022; Bill filing is 2nd week of Jan., will join again then to advise what/if any bills are presented of special interest to VAC; worked with States Atty. on details of power of States Atty to offer services to VAC; Discussion:
    - Glasgow stated resistance to legislation was optional to VACs across the state, will have a Asst. States Atty Chris Wise at all VAC meetings going forward
    - Picciolo asked McNichol to give background on why States Atty was needed; McNichol stated over the last several years there have been numerous occasions VAC has needed legal services,

should be a way to use taxpayer-funded existent legal services; states post Covid office has grown, has received \$2.2 million in grants, needs to maintain correct legal stance; Chris Wise will be primary contact

-Glasgow stated McNichol was the one WCVAC Superintendent who saw the need, example of FOIAs being difficult

B. Guardian Angel Services; Intro & Overview of Guardian Angel Services in Will County- Janice Masokas-Joliet, Plainfield, Crete, Grundy offices, programs for sexual assault and domestic violence; 24 hr hotline for victims and families of victims; provide free medical and legal advocacy, not attorneys, will accompany victims to court/navigate legal ramifications of assault; meet at ER, pay for emergency medical services, survivors do not pay for treatment; provide prevention by going to schools, teaching how to disclose, recognize, report abuse/assault, preschool thru college: Discussion:

-Blue requested contact info, flyer with contact info, thanked J. Masokas for services provided, she will provide email to VAC

-McNichol advised VAC partnered with Guardian Angel to provide services thru the pandemic, states VAC referred to Guardian Angel for veterans

A. McNichol advised nearly \$90 million in awards will be received thru 2023

B. Award Log: McNichol advised per Governors Report, in 2020, VAC VSOs assisted Will county veterans in receiving over 76% of new awards of nearly \$20 million; advised VSO go into Fed. database to track new awards, states nearly \$5 million in 2021 to date; Financial Assistance is part of VAC budget, decreased 46% due to changes in policy to consecutive 6 months every 2 years, states 86% decrease 2020-2021; states w/in CoC, only 2 veterans have received Fed. financial assistance; advised per Governors Report, no transport assistance dollars spent since mid-2017 due to Will County States Atty, others, eliminated need for bus passes, occasional need now filled by Our Patriots: Discussion:

-Blue advised no busses in Monee, how do we get the info to veterans if they have a need, if busses/transport services are needed; Picciolo advised individual Posts/Legions are to share information with local veterans thru their Service Officers, states Nagel is Pres. of her Auxiliary, -Nagel stated need for more brochures at her

-Nick Reiher, Farmers Review states they are expanding coverage to Monee, keeping presence in Peotone, states part of the reason is to bring info to eastern Will County thru partnership with VAC, requested any information to be forwarded to him for publication on "Page 5"

-Picciolo advised need more participation from Posts/Legions at VAC meetings to disseminate information to their organizations

C. Project 150 Report:

a) McNichol advised ESG grant community partners, over 30% of housing services have come from non-veteran specific providers

b) McNichol advised VAC has spent \$267K of \$375 to date thru Covid, advised avg. rent is \$1100 going back into Will County local economy; shows how investment in affordable housing positively impacts local economy; Discussion:

-Nagel states work for GSU, referenced Kevin Smith from GSU; McNichol advised K. Smith was on a panel with her at inception of Illinois Joining Forces, invitation to participate will be sent

-Horne requested copy of Governors Report, McNichol advised will be sent to Board Members

-Wise advised point of order, legislation allowing remote meetings require roll call on all votes
